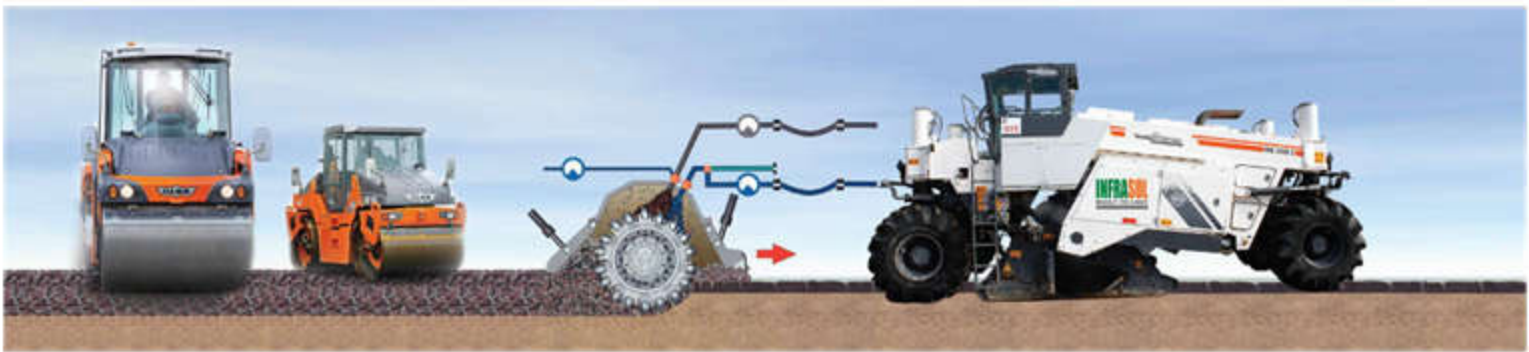

To meet the rising demand for infrastructure development and modernizing construction technology, **INFRASOL JSC** was the first to introduce Cold-in-Place recycling (CIR) with foamed bitumen and cement from Wirten Group (Germany) in Vietnam for maintenance, stabilizing roadways and airport runways.

CIR is a pavement rehabilitation method using pavement milling to remove and reuse existing asphalt surface, which has been successfully applied to various major infrastructure projects in Ho Chi Minh City and Vietnam's National Highway (NH) such as NH no. 1A (Binh Dinh, An Suong segments), NH no.5 (Hai Phong), NH no.1 Cu Mong pass – South Binh Dinh segment, NH no. 1 Long An segment, NH No.70 (Yen Bai), NH no.48 (Nghe An), Vinh Bypass road (Nghe An), Phu Bai Airport – Hue,... **Cold-in-Place recycling (CIR)** with foamed bitumen and cement is a low-cost, high production rate and environmentally friendly due to the recycling of old materials yet still maintaining the product quality. Various investors and state managing agencies such as Vietnam's Department of Roads and the National Traffic Safety Committee (Ministry of Transportation) have both praised CIR.

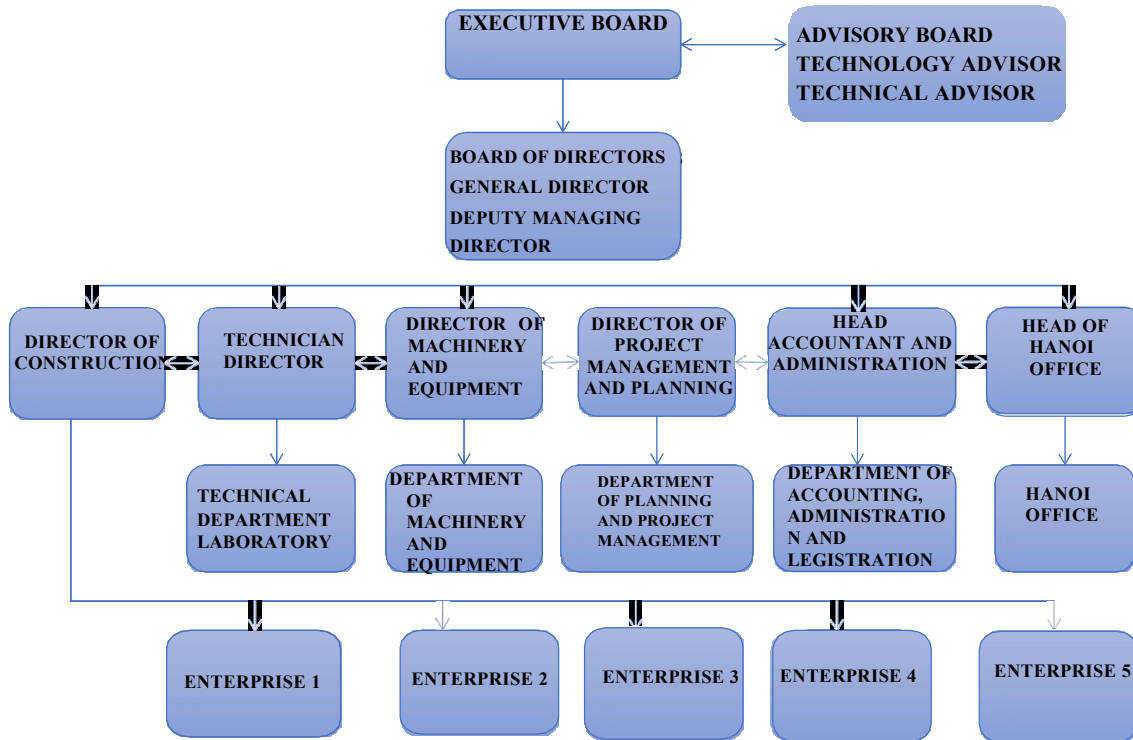

1. RECYCLING PAVEMENT USING FOAMED BITUMEN AND CEMENT

By utilizing existing pavement upper layer and foundation materials in roadway maintenance, upgrade or expansion, CIR has become the most advance and modern technology. There are two primary methods of recycling: hot recycling and cold in-place recycling (CIR). Hot recycling can be done in place or at a batching plant. CIR is primarily done in place. The existing asphalt layer and a portion of the base-course is milled, mixed with new bonding materials to make a solid layer which can fulfil different roles and locations within the pavement structure.

Bonding material can be categorized into 4 main categories:

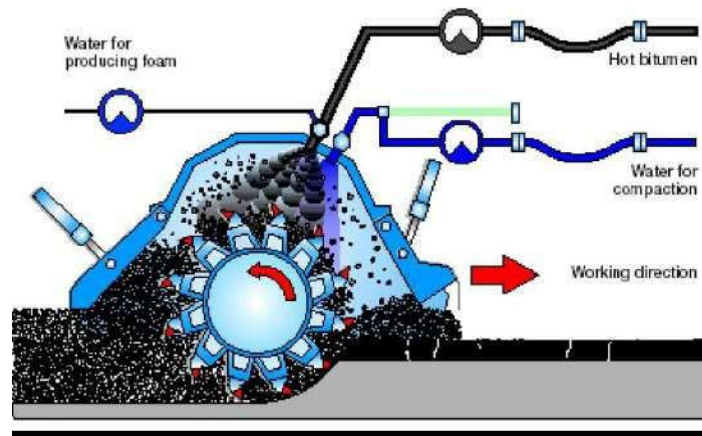
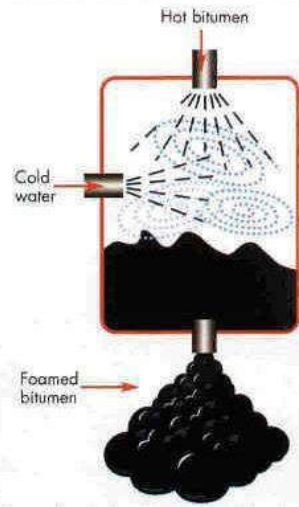
- Cold recycle with emulsion (Emulsion recycling);
- Cold recycle with foamed bitumen (foamed bitumen recycling);
- Cold recycle with emulsion or bitumen and cement
- Cold recycle with hydrants (lime, cement, fly ash...).

Currently, the cold in-place recycling method has been introduced in Vietnam. INFRASOL JSC was the first to adopt this method of recycling using foamed bitumen from Wirtgen Group from Germany.

It can be said that this is the joining of technology and science. Technology platform has created favorable conditions for applied science in the field of road development.

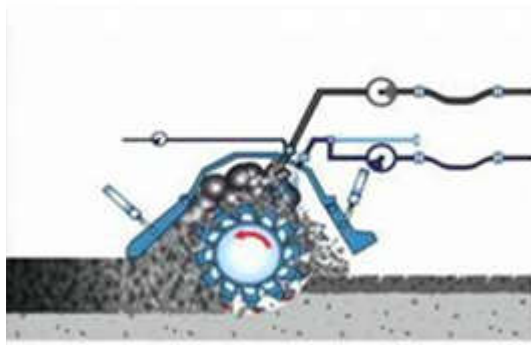
Definition: Foamed bitumen is a mixture of air, water and hot bitumen. Meaning, hot bitumen is injected with water rays which results in the bitumen foaming and expanding many times its original volume

2. SEMI-FLEXIBLE PAVEMENT (SFP)

Definition and Terminology:

- **Semi-flexible pavement** is a new pavement technology consisting of open-graded asphalt concrete with a high air void content filled by injecting special grouting materials.
- These new pavement materials are simultaneously possessing the flexible characteristics of asphalt pavements and the high strength (hardness) of concrete pavements. For these reasons, SPF is suitable for high traffic, and heavy load, requiring good settlement resistance roadways.

3.MICRO-SURFACING

Terminology and definition:

- **The micro-surfacing mixture** is a mixture consisting of crushed stone aggregate, Polymer asphalt emulsion, water, mineral powder and additives mixed according to the design specification and mixed by cold mixing and spreading method.
- Micro-surfacing mixtures with spreading thicknesses from 6mm – 15mm are manufactured and applied at ambient temperature.
- Traffic can be allowed to pass after 1 hour and at a temperature of 24C and humidity of 50%

Application and advantages:

- The micro-surfacing mixture is widely used for roadway maintenance around the globe;
- ✓ *Repair asphalt defects such as peeling, and draindown ;*
- ✓ *Improve roughness and rutting of the pavement.*
- Micro-surfacing mixtures have the following advantages:
 - ✓ *Slows down oxidation and ageing of pavement upper layer;*
 - ✓ *Prevent water from entering the pavement structure;*
 - ✓ *Improve pavement's slip resistance.*

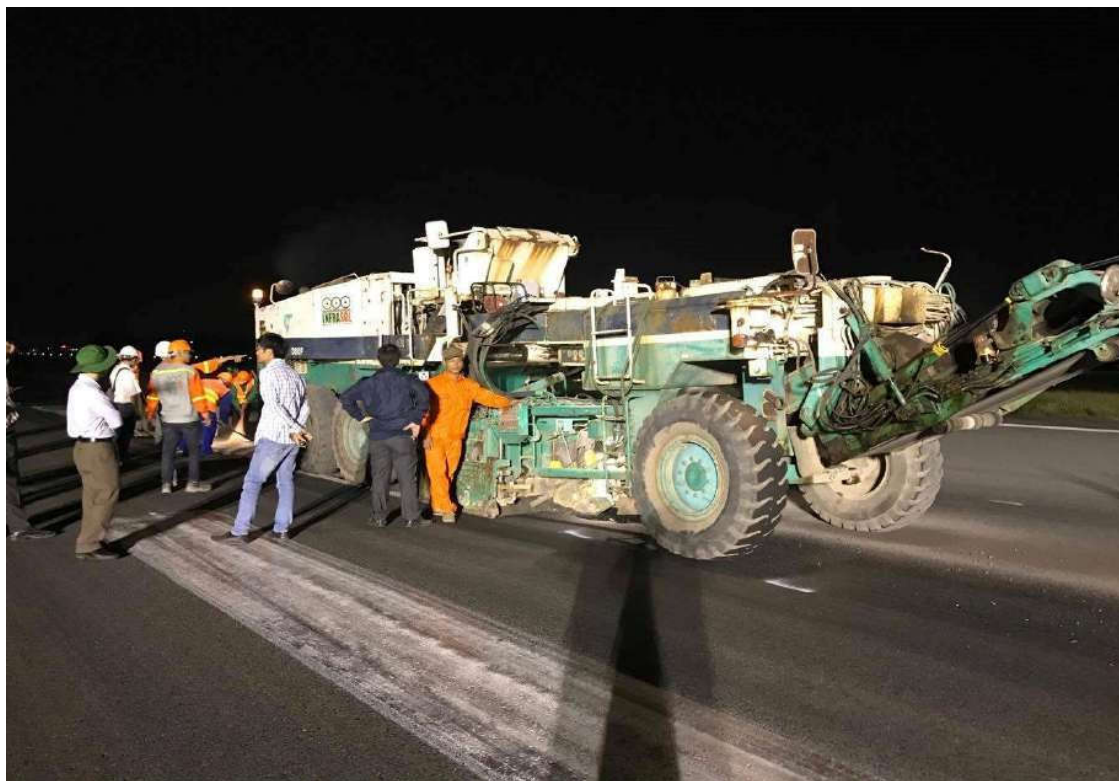
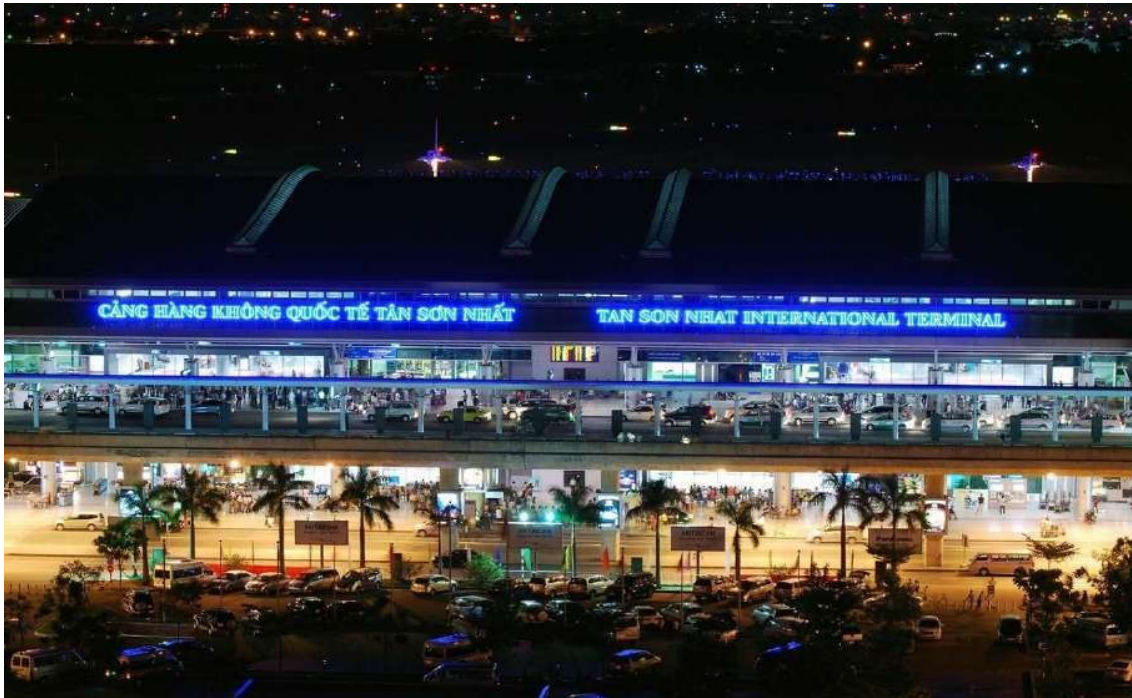
